This interdisciplinary regional conference brings together leaders involved in efforts to address diverse challenges that impede effective pain control. Participants can share resources and expertise, network with one another and become energized to assist patients in pain by evaluating and treating it in the best possible way. The 2008 event focuses on the epidemiology and neuroscience of pain, state of the art best practices in pain management, challenges and solutions in accessing effective pain management, and risk management and legal issues regarding the prescribing of opioids.

KEYNOTE SPEAKER BIOS

SCOTT FISHMAN, MD

Dr. Scott M. Fishman is Chief of the Division of Pain Medicine and Professor of Anesthesiology and Pain Medicine at the University of California, Davis. Dr. Fishman lectures on all aspects of pain and its treatment throughout the US. He has authored “The War on Pain” through Harper Collins Publishers and “Listening to Pain” through Waterford Life Sciences. He has also co-authored “The Massachusetts General Hospital Handbook of Pain Management” (Lippincott) and Essentials of Pain Medicine and Regional Anesthesia (Elsevir.) He has recently authored “Responsible Opioid Prescribing” for the Federation of State Medical Boards which will be available to all US prescribers through state medical boards.

Dr. Fishman’s clinical interests include cancer related pain management, peripheral and central neuropathic pain, chronic opioid usage, and spinal injection therapies. His major research interests include models for functional assessment and pharmacovigilance in chronic opioid therapy, legal issues and regulatory policy on pain care, novel analgesic therapies, models of visceral pain, models of hyperalgesia and central sensitization, informatics strategies to serve clinical practice, quantitative sensory testing in acute and chronic pain states, neuronal plasticity and brain imaging in pain.

NATHAN J RUDIN, MD, MA

Dr. Rudin joined the University of Wisconsin Rehabilitation Medicine faculty in 2001 after six years on the Johns Hopkins faculty, and is Medical Director of the UW Pain Treatment and Research Center. He is an active teacher, author and researcher, and has served on national and statewide task forces developing guidelines for chronic pain management. Dr. Rudin was the inaugural recipient of the Rehabilitation Institute of Chicago’s first endowed residency award, the Joanne S. Crown Residency, which recognizes “understanding, compassion and appreciation of quality of life issues for patients.” The UW Rehabilitation Medicine residents have twice awarded him their annual Clinical Teaching Award for excellence in instruction and mentorship. Dr. Rudin serves on the Board of Directors of the Midwest Pain Society. This year UW Pain Care Services was recognized by the American Pain Society as a Clinical Center of Excellence in multidisciplinary pain care.

JUNE DAHL, PHD

Dr. Dahl is Professor of Pharmacology at the University of Wisconsin School of Medicine and Public Health. She received a PhD in Physical Chemistry and spent many years in basic research before turning her attention about twenty years ago to efforts to bring improvements in pain management. Her focus on pain began when she was serving as Chair of Wisconsin’s Controlled Substances Board and co-founded the Wisconsin Cancer Pain Initiative with David Joranson. She currently serves as advisor to the Alliance of State Pain Initiatives and remains involved in work directed at the knowledge, regulatory, and system barriers responsible for the undertreatment of pain.
